This Memorandum of Understanding is made and executed on this day the 10th day of October 2023.

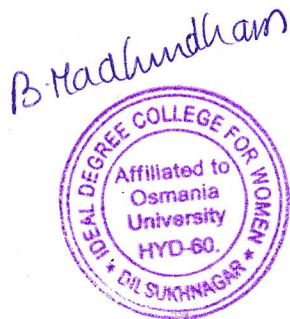

Whereas the First Party is a Private Intermediate & Degree College in the state of Telangana. And that it intends to encourage vocational training among girls & women to help them learn skills that could be useful in advancing their career and as a tool to attain employment / self-sufficiency in life. That it recognizes that courses offered by the Second Party are useful skills to be imparted to female candidates to help them in personal grooming and as a viable employment option.

And whereas, the Second Party is a Training Partner of the National Skill Development Corporation (NSDC); with operations in Hyderabad and has been in the business of training Beauticians and Fashion Designers in Junior and Degree Colleges, and at its institute since 1993. That it has successfully executed the Beautician Course in Government and Private Degree colleges in Hyderabad and in other districts of Telangana and Andhra Pradesh, since 2002-03. And as a Training Partner with the NSDC, it also conducts various courses in association with various sponsor organizations, in the Beauty & Wellness and Apparel Sectors, at its institutes.

And whereas, both parties agree to collaborate to extend training facilities to female candidates, who are interested to undertake training for personal and professional reasons.

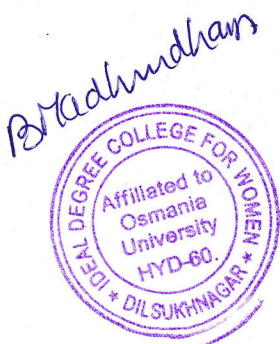
Whereas the Second Party has proposed that it is willing to conduct the Beautician's course at the college premises. This is conducted in association with the NSDC, and certificates are issued by the NSDC; and are valid worldwide. It is a short-term course spread over a period of 3 months (inclusive of the assessment and certification). The classes will be conducted outside the college hours in a dedicated space. The candidates are required to pay a sum of Rs. 1250/- (Rupees One Thousand Two Hundred & Fifty Only) towards training & assessment fee and cost of material to be used in the class. All material required for the conduct of the course in the college premises will be provided by the Second Party. An assessment will be conducted on completion of the course and successful candidates will be awarded a certificate by the Second Party.

The Second Party will conduct its approved courses at the college. The college will have no role in the conduct, supervision or certification of these courses.

**Key Responsibility Areas – The First Party (Ideal Degree College, Dilsukhnagar, Hyderabad).**

- 2-3 furnished classrooms for conducting the classes.
- Timings – 1 hour before and/or after college hours as required for different batches.
- General upkeep and cleanliness of the leased premises.
- Electricity & water supply.

**Key Responsibility Areas – The Second Party (Fairy Princess Institute LLP).**

- Counseling & enrollment of candidates.
- Course delivery with content & material for use in practical's.
- Conduct of examination, internal & final evaluation of candidates and results.
- Award of certificates to successful candidates.

**Payment Terms**

- The Second Party will pay to the First Party a sum of Rs. 100/- per candidate for utilizing the premises to conduct its courses as mentioned above. This amount will be paid by cheque.

**Notes:**

1. The First Party will allocate the requested space and infrastructure to the Second Party.
2. The Second Party will undertake the responsibility to provide the material and the resource person(s), to be used in the conduct of the said courses.
3. The Second Party can enroll any number of candidates into its courses, it deems deliverable.
4. The Second Party will provide feedback to the First Party regarding the number of candidates enrolled and trained every year.
5. This arrangement will be valid for a period of 5 years and renewable subsequently every three years.
